Notes to Exhibitors

- "The AKC will collect a \$3.50 Event Service Fee and 50 cent Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the event fees will be collected on each entry" - Chapter 11, Section 2 of the AKC's *Rules Applying to Dog Shows*. AKC's Recording Fee for Rally is \$3 per entry. A show-giving club shall assume the responsibility of collecting all recording and event fees for AKC.
- No refund will be given for duplicate entries.
- No refund will be given for bitches that come in season after entries close. Bitches in season are not permitted at the show site.
- Owners are responsible for accuracy of information on the entry forms. After the closing date, no entry fees will be returned in the event of errors or cancellation of entries. Entries will not be accepted without fees or signature.
- An entry will not be accepted that is not on an official AKC entry form that includes the agreement.
- Returned checks do not constitute a valid entry fee. The Event Secretary will add a \$50 collection fee to the amount of each returned check.
- No entry fee will be refunded for a dog that is absent or is excused or disqualified by the judge or barred from competition by action of the Trial Committee.
- No entry fee will be refunded if the trial cannot open or be completed because of riots, civil disturbances, fire, extreme and/or dangerous weather, act of God, public emergency, act of public enemy, or any other cause beyond the control of the club or the Event Secretary.
- Entries submitted by phone, fax, or e-mail will not be accepted.
- Changes, additions, or corrections to entry forms must be submitted in writing or via email and received by the **TRIAL SECRETARY BEFORE 6:00 pm, Wednesday, February 22, 2012**
- All checks and money orders must be in US funds.
- **TRIAL HOURS: 7:30 AM-6:00 PM EACH DAY**
- Smoking is not permitted inside the building.
- The building will be available to exhibitors Friday, March 9th during Rent A Ring and starting at 7:30am on Saturday, March 10th. Crates and chairs may remain in the building overnight. Dogs must be removed from the building within 30 minutes after completion of judging each day. Because crate space is limited, we'd appreciate your use of stackable crates
- Judging procedures may be modified to accommodate disabled handlers.
- Park in designated areas only.
- Bring your own shade, chairs and beverages. Lunch is available from nearby fast-food and full-service restaurants.
- All dogs must be on lead both inside and outside the building except

when in the ring.

- Judges will not wait for dogs holding up a ring.
- At both the show site and the motels, please pick up after yourselves and your dogs.
- Dumpsters in and around the parking lot *may not* be used for ANY trash.
- Any complaints from motels regarding exhibitors may result in a Trial Committee hearing.
- Entries are acknowledged via email as received. Entries are confirmed and the judging program is distributed via email when all entries are processed, final judging assignments are complete, and exhibitor armband numbers have been assigned.
- **Move-ups** will be accepted per AKC regulations if the class is not full. Completed and signed move-up form must be submitted to the Trial Secretary no later than **30 minutes** prior to the start of judging

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1887, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companionship. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
